1. Regulation Market Issues Sr. Task Force (RMISTF) (1:25-1:45)

Mr. Keech presented proposed Tariff and Operating Agreement (OA) revisions related to regulation market enhancements endorsed by the RMISTF and the Markets & Reliability Committee. Following discussion, the committee **endorsed/approved** the proposed revisions in a sector-weighted vote with 4.24 in favor.
