2. <u>Frequently Mitigated Unit Adders</u>

Ms. Ford reviewed the results of the FMU matrix polling survey issued to members. Stakeholders were given an opportunity to further refine solution packages. Package C was withdrawn and a new solution package F was added. The most recent update to the matrix has been posted to the February 25th meeting materials. A request was made for additional meetings to discuss the FMU topic. Ms. Ford provided a tentative schedule (noted below) for MC approval in June.
