#### ADMINISTRATION (9:00-9:05)

Mr. Anders welcomed and reminded participants of Anti-trust and Code of Conduct requirements.

#### **ENDORSEMENTS/APPROVALS**

#### 1. ADMINISTRATION (9:05-9:10)

Minutes of the February 23, 2012 Markets and Reliability Committee (MRC) meeting were <u>approved</u> by acclamation with no objections or abstentions.

#### 2. PJM MANUALS (9:10-9:40)

- A. Mr. McGlynn reviewed revisions to PJM Manual 14A regarding unit output.
- B. Mr. Dessender reviewed revisions to Manual 28: Operating Agreement Accounting addressing the fixed costs to be paid to Demand Resources responding to Synchronized Reserve Events. The Cost Development Subcommittee will be asked to develop the definition of shutdown costs to be included in make-whole payments.
- C. Mr. Keech reviewed various revisions to manuals 11, 12, 13, 28 endorsed by the Operating Committee.

Following discussion, the MRC <u>endorsed</u> the proposed revisions in items 2A, 2B and 2C by acclamation with no objections and one abstention.

# 3. FERC ORDER ON REMOVING NON-RELIABILITY MONITORED FACILITIES FROM PJM LOSS CALCULATIONS (9:40-10:10)

Mr. Bresler discussed proposed Tariff and Operating Agreement (OA) revisions prepared in response to the recent FERC order rejecting the proposed marginal loss calculation change (ER11-3445-000). He reviewed discussions of this topic at the Market Implementation Committee (MIC) and MRC. Following discussion, the motion <u>failed</u> in a sector-weighted vote with 3.17 in favor. Mr. Kormos noted that this item had been noticed as being on the Members Committee agenda for its March 29, 2012 meeting, but would not be voted upon unless moved and seconded by a Member. In response to questions, he noted that staff may recommend that the Board of Managers take action on this issue.

#### 4. BLACK START REFURBISHMENT (10:10-10:30)

Mr. Schweizer presented proposed Tariff and Manual 14D revisions to implement the Black Start Refurbishment Process and resulting proposals developed by the Black Start Service Task Force. Following discussion, the main motion, proposal B, <u>failed</u> in a sector-weighted vote with 1.96 in favor. The alternative motion provided by the Market Implementation Committee (MIC), proposal A1, also <u>failed</u> in a sector-weighted vote with 0.37 in favor. Mr. Schofield moved and Mrs. Bruce seconded an additional alternate proposal, proposal C. This motion also failed in a sector-weighted vote with 1.80 in favor.



#### 5. COMBINED CYCLE MODELING (10:30-10:45)

Ms. Walter presented a proposed Problem Statement and associated draft charge regarding Combined Cycle Modeling. Following discussion during which it was determined that the issue would be assigned to the Operating Committee, there was no objection to undertaking the Problem Statement, and the Charge was <u>approved</u> with no objections or abstentions.

#### SYSTEM RESTORATION STRATEGY TASK FORCE (SRSTF) (10:45-11:00)

Ms. Hendrzak presented the draft charter for the SRSTF. Following discussion, the MRC <u>approved</u> the proposed revisions by acclamation with no objections or abstentions.

#### **FIRST READINGS**

#### 1. PJM MANUALS (11:30-11:40)

- A. Mr. Keech presented proposed revisions to Manual 1 due to implementation of AC<sup>2</sup> and other cleanup revisions. The MRC will be asked to endorse these proposed revisions at its next meeting.
- B. Mr. Sims discussed a proposal regarding the amount of generation scaled by the PJM Generation Deliverability Test and associated draft PJM Manual 14B language. The MRC will be asked to endorse these proposed revisions at its next meeting.

#### 2. RPM RELATED ISSUES (11:40-12:10)

Mr. Anders discussed results of polling related to longer-term RPM associated issues submitted by stakeholders for consideration in future stakeholder process activities as well as draft Problem Statements related to Demand Response Issues, Report and Energy Markets Obligations, Transmission/RTEP Issues, and Other – Review Timing. Although this is a first read, due to timeliness of the issue, the committee was asked approve a Problem Statement and charge associated with the Long Term Auction scope of work. Mr. Ruch proposed a friendly amendment to add to the charge that the proposed auction be competitive, non-discriminatory and not distortive to the existing Base Residual Auction. Mr. Schofield objected, and therefore this was not considered friendly. Mr. Tatum proposed that the term "voluntary" be removed from the Problem Statement. Several Members objected to this being friendly, and therefore it was not considered friendly. Mr. Hoatson proposed a friendly amendment to replace the second paragraph of the Problem Statement with the section of the FERC order describing the specific commitment and to remove the term "voluntary" from the Problem Statement. Mr. Fitch requested that the last statement of the original document not be stricken from the last paragraph of the Problem Statement. There were no objections to either of these two proposed amendments, and therefore they were considered friendly. There was no objection to pursuing this issue and therefore the Problem Statement was considered approved. Following discussion, the Charge was approved by acclamation with two objections and two abstentions. It was agreed that a special meeting of the MRC would be convened in April for the purpose of performing the first read of the other four Problem Statements/Charges, and that the MRC would be asked to approve these Problem Statements/Charges at the regularly scheduled April 26, 2012 meeting.

# 3. QUALITY PROJECT PROCESS IMPROVEMENTS (12:10-12:25)

Ms. Hugee discussed revisions to Tariff Attachment M identified through PJM's Quality Project related to process improvements in the flow of information between Members, the Independent Market Monitor and PJM. This item will be added to the agenda for the April special RPM related MRC meeting for the first read. The MRC will be asked to endorse these proposed revisions at the regularly scheduled April 26, 2012 meeting.

#### 4. IRM ASSUMPTIONS (12:25-12:35)

Mr. Falin reviewed the draft 2012 IRM assumptions letter. He noted discussion of the draft letter at the Planning Committee (PC).



# 5. ADDITIONAL SECTIONALIZING SCHEMES (12:35-12:45)

Mr. Daniels reviewed the West Shore sectionalizing schemes in the PP&L zone to be incorporated into Manual 3: Transmission Operations. He noted that this scheme has been in place as it is an N-1-1 scheme, and not required to be included in M3. He noted that it was being reviewed with the MRC at this time because other planned system conditions will result in this becoming an N-1 contingency, and therefore will be added to M3.
