1. Five Minute Dispatch and Pricing

Tim Horger and Vijay Shah provided an update regarding Five Minute Dispatch and Pricing and reviewed a proposed solution addressing the short-term. Greg Poulos, CAPS, noted his intention to propose the Independent Market Monitor's proposal from the Market Implementation Committee as an alternative motion should the main motion fail. Following discussion, the committee **<u>endorsed</u>** the proposed solution including proposed Operating Agreement (OA) and Tariff revisions in a sector-weighted vote with 5.0 in favor. Stu Bresler noted that Members Committee (MC) endorsement/approval will be sought on the same day. Greg Poulos objected to voting on the same day at the MC. Stu Bresler acknowledged the objection and indicated that the objection would be addressed at the MC.
