A second vote showed stakeholders preferred the PJM proposal over status quo with 188 (100%) in favor, 0 (0%) opposed, and 2 abstentions. The committee did not endorse the IMM proposal B with 32 (17%) in favor, 157 (83%) opposed, and 6 abstentions. A second vote showed stakeholders did not prefer the IMM proposal over status quo with 32 (17%) in favor, 157 (83%) opposed, and 6 abstentions. The committee did not endorse the IMM proposal C with 32 (17%) in favor, 157 (83%) opposed, and 6 abstentions. A second vote showed stakeholders did not prefer the IMM proposal over status quo with 32 (17%) in favor, 156 (83%) opposed, and 6 abstentions.

The PJM/PSEG/DC Energy proposal will move on to the Market and Reliability Committee (MRC)





as the main motion with 100% support and 100% preference over status quo.
