Working Issues

1. Update on New FTR Credit Requirements Implemented in 2018

Brian Chmielewski, PJM, presented an update on the new FTR credit requirements reflecting transmission upgrades which were implemented this spring.

2. RPM Credit Requirements for At-Risk Existing Resources

PJM presented draft tariff language changes. The CS will continue discussion of the issue using a matrix to identify options for design components.
