## Administration

## Working Issues

1. Reminder – Holiday Submission Deadlines

Mr. Ray Fernandez, PJM, reminded the Subcommittee of the importance of timely Power Meter and InSchedule submittals during holiday deadline extensions, highlighting the various issues it causes within PJM Market Settlements.

2. FERC Order 825 – Discussion on Sub-Hourly Settlements

Mr. Ray Fernandez, PJM, discussed the announcement to push back the implementation of 5-mintue settlements to April 1, 2018 and summarized the issues discovered during the first Market Trial for the operating day of November 13, 2017. PJM is targetting December 15 as the next Market Trial operating day.

Additional Market Trials are planned for Ancillary Services and Operating Reserves, and are scheduled to begin in late January or early February. PJM will communicate all report updates to the Market Settlements Subcommittee email distribution list.

Mr. Sean Flamm, PJM, provided details on the EPT Interval Ending format for the DST day and the addition of Hour Ending columns to specific 5 minute level reports. PJM will be moving forward with the addition of the new Hour Ending columns.
