Maria Baptiste provided an update on the latest and upcoming eDART release. eDART Browserless refresh is completed in eDART and will be retiring the legacy browserless feature in production on November 1st, 2023. The eDART Account Migration to Account Manager is underway until December 13th, 2023. PKI Certificates are now required for all browserless communications, there is a new PJM CLI jar file, and SUMA will not be enabled for eDART in Account Manager. Future release includes enhancements to TERM application in response to FERC Order 881. A high-level timeline through MidJune 2025 was provided.
