Administration

Mr. Anders opened the meeting and reviewed the agenda. Ms. Egan collected attendance, provided the Anti-trust and Code of Conduct announcements.

Package Discussion

Package sponsors were given the opportunity to provide reviews of their current proposals. Both PJM and the IMM presented updates to their package proposals. Based on feedback and questions from stakeholders, an additional meeting has been scheduled on November 10 to further review these updates. All other proposals remain unchanged (AMP, Exelon, LS Power, NRDC, NRG and NOVEC).

Next Steps

Mr. Anders noted that a vote would take place after the newly scheduled meeting of the CCPPSTF, on November 10. This vote will open on November 13 and will close on November 17. Results of this vote will be reviewed at the November 21 meeting. Any proposal receiving simple majority support will be taken to the December 7 MRC meeting for a first read. Of note, some stakeholders voiced objections to the timing of this vote, while others provided comments in support of this vote on proposals taking place as planned.
