#### Administration and Work Plan

Ms. Anita Patel opened the meeting.

Ms. Michele Greening will provided announcements and review of the Antitrust, Code of Conduct, and Public Meetings/Media Participation Guidelines. No media representation were announced as present at the meeting. Stakeholders approved draft minutes from the September 5, 2019 meeting as posted with no objections registered.

Ms. Nigeria Bloczynski provided an update to the Financial Risk Mitigation Senior Task Force regarding credit policy updates and the review of stakeholder feedback in preparation for updates to be provided at the October FRMSTF. Ms. Anita Patel reviewed the Financial Risk Mitigation Senior Task Force stakeholder process work plan and voting schedule timeline. She also reviewed a proposed FRMSTF Charter revision to update the Expected Overall Duration of Work to reflect fourth quarter rather than third quarter for Key Work Activity 5. No objections were registered for the change. The revision will be taken for review and endorsement by the Markets and Reliability Committee (MRC) at its September 26<sup>th</sup> meeting.

Mr. Brian Chmielewski reviewed results of the vote on FTR Product Range and Auction Process Solution Packages and discussed next steps. The PJM/Vitol Package received the highest level of support with 75% in favor and will be brought to the MRC in October for first read. Corresponding language revisions will be drafted and presented for review at the FRMSTF meeting on October 17th and taken for first read to MRC on October 31st. Endorsement will be sought at the MRC meeting on December 5th with a targeted filing planned for end of this year.
