RAA, section 1.58	"Operating Reserve" shall mean the amount of generating capacity scheduled to be available for a specified period of an Operating Day to ensure the reliable operation of a Control Zone <u>the PJM Region</u>, as specified in the PJM Manuals. OA, section 1.28	Operating Reserve is used to ensure reliable operation of the PJM Region, not just a Control Zone, as properly reflected in the RAA's definition. PJM used to be controlled and operated on a Zonal basis, however for several years, PJM has controlled and operated the entire RTO and does not operate it on a sub- RTO basis. The definition in the RAA is thus appropriate.
