

Members Committee One Hundred Eighty-third Meeting The DoubleTree Hotel, Wilmington, DE December 6, 2018 1:15 p.m. – 5:00 p.m. EPT

Administration

- A. Mr. Anders announced the following new member companies approved for PJM membership since the last meeting, bringing the total membership to 1027:
 - Dominion Energy Fairless, LLC (Affiliate Member) selected the Generation Owner sector
 - FiTran Fund LP (Voting Member) selected the Other Supplier sector
 - Geenex Solar LLC (Voting Member) selected the Generation Owner sector

Mr. Anders noted that 23 members had withdrawn since the last meeting.

- B. Mr. Anders confirmed the presence of a quorum.
- C. Mr. Anders reminded participants of Antitrust and Code of Conduct requirements.

Mr. Mike Borgatti noted that Item 1 on the posted agenda was moved to the Consent Agenda as Item B; there were no objections.

Mr. Andy Ott discussed the December 5, 2018 letter from the PJM Board of Managers regarding market monitoring services.

1. <u>RPM Credit Requirement Reduction Clarifications</u>

This item was moved to the Consent Agenda.

2. Price Responsive Demand Review for Capacity Performance Requirements

Mr. Pete Langbein presented proposed Operating Agreement (OA) and Tariff revisions related to Capacity Performance changes required for Price Responsive Demand. Following discussion, the proposed revisions were <u>approved/endorsed</u> by acclamation with 15 objections and one abstention.



3. Gas Pipeline Contingencies

Mr. Richard Brown presented proposed OA and Tariff revisions related to Gas Pipeline Contingencies. Mr. Erik Heinle proposed a friendly amendment to remove the automatic inclusion of penalties and the eligibility for recovery gas contingency costs. There were no objections to this being friendly, and therefore this was included in the main motion. Following discussion, the proposed revisions were <u>approved/endorsed</u> in a sector-weighted vote with 4.26 in favor.

4. Elections

5. Bilateral Counterparty Assumption Filing

Noting receipt of the related November 30, 2018 FERC deficiency letter, Ms. Daugherty discussed withdrawing PJM's October 1, 2018 filing in Docket No. ER19-24 that requested bilateral counterparties have the option to assume certain FTR positions of a defaulting member. Following discussion, Mr. Bob O'Connell, Panda, moved and Mr. Bruce Bleiweis, DC Energy, seconded a request for an advisory



vote recommending withdrawal of the filing. The Members <u>endorsed</u> PJM's withdrawal of the subject filing by acclamation with six objections and 11 abstentions.
