David Anders noted that in response to a sector challenge made in accordance with Operating Agreement (OA) section 8.1.3, the following sector changes were made effective October 29, 2020 (in advance of this meeting):

- Gerdau Ameristeel Energy is changing from the Other Supplier sector to the End-Use Customer sector
- Indiana Municipal Power Agency is changing from the Generation Owner sector to the Electric Distributor sector
- Kentucky Municipal Energy Agency is changing from the Other Supplier sector to the Electric Distributor
- Kuehne Chemical Company is changing from the Other Supplier sector to the End-Use Customer sector
- Northern Illinois Municipal Power Agency is changing from the Generation Owner sector to the Electric Distributor sector
- Procter & Gamble Paper Products Company is changing from the Generation Owner sector to the End-Use Customer sector

Additionally, David Anders noted that as a result of its review of Kentucky Municipal Energy Agency, PJM learned of a Related Party relationship with Owensboro Municipal Utilities which is in the Other Supplier sector. As a member of the Other Supplier sector not eligible to become an Electric Distributor and a Related Party to a member of the Electric Distributor sector, it is no longer considered a voting member per OA section 8.1.2

2. Liquidation Process

Nigeria Bloczynski reviewed proposed Tariff and OA revisions addressing PJM's default management process. Steve Lieberman noted that this item had been endorsed by the Markets & Reliability Committee on the same day (at its October 29, 2020 meeting); there were no objections to voting on the same day as the MRC.
