Susan Bruce, PJM Industrial Customer Coalition, and Sharon Midgley, Exelon, reviewed a proposed compromise solution and corresponding Tariff revisions addressing Black Start Unit Involuntary Termination, Substitution Rules, Capital Recovery Factor (CRF) and Minimum Tank Suction Level (MTSL). Following discussion, the vote on the proposal <u>failed</u> in a sector-weighted vote with 3.17 in favor.
