### Administration (9:00 – 9:15)

1. Dave Souder, PJM, called the meeting to order. Marilyn Jayachandran, PJM, reviewed the Antitrust, Code of Conduct, media participation, and WebEx guidelines.
2. Marilyn Jayachandran reviewed the March 8, 2022 Planning Committee agenda. No changes to the agenda were requested.
3. Marilyn Jayachandran reviewed the draft February 8, 2022 Planning Committee meeting minutes and the committee approved the minutes

### Endorsements (9:15 – 9:30)

4. Deactivation Process Timing  
Dave Egan, PJM, provided a second read of the proposed solution to the deactivation process timing issue. No changes have been made since the February first read.

**The committee approved the issue charge and endorsed the proposed solution as part of the Quick Fix process outlined in Section 8.6.1 of Manual 34. There were 148 Yes Votes, 2 No Votes, and 13 Abstain. The committee also approved the proposed solution over the status quo with 109 Yes Votes, 22 No Votes, and 26 Abstain.**

Joseph Hay, PJM, provided a first read of Manual 14F regarding the biennial cover-to-cover review. The committee will be asked to vote on the manual changes at next month's meeting.

Joshua Bruno, PJM, provided a first read of Manual 21A revisions regarding an ELCC model run timing update and changes to reflect the continuation of the current method to provide unit specific backcasts only as requested. The committee will be asked to approve an Issue Charge and endorse the proposed Manual 21A revisions as part of the Quick Fix process outlined in Section 8.6.1 of Manual 34 at next month's meeting.
