Both eFTR train and production environments will be retired during 4th quarter 2016. A future update will be provided with exact retirement timeline. Since all tasks performed in FTR Center during parallel operations will also be created in eFTR, there is no need to use both systems for the same tasks. While no functionality or business rules have changed in the development of FTR Center, new security controls will impact participants implementing browserless communications in FTR Center.
