Issue Summary

1. Recommended Proposal

The MIC Special Session- Fuel Cost Policy Enhancements group developed a single proposal - the PSEG Package. This package proposes the development of an Information Only Cost-Based Offer calculator. This calculator will provide a non-binding three part Cost-Based Offer (Start up, no load and incremental energy offer) by midnight prior to the market day. The calculator can be used as a comparison with the Market Seller calculated offer and increases the transparency of the input variables used in the development of the cost-based offer.

This calculator helps the Market Seller reduce compliance risk as well as the likelihood and extent of penalties for submitted non-competitive cost-based offers. The use of the Information Only calculator is optional and Market Sellers are still responsible for the accuracy of their cost offer. No manual or tariff changes are required for this proposal. The tentative timeline for full project implementation is 2022 but interim steps and detailed design discussions would occur in 2021 at the Cost Development Subcommittee (CDS) meetings.
