Administration

Endorsements/Approvals

2. **Manual 15 Revisions - Incremental & No Load Energy Offer**

Tom Hauske provided an overview of the Manual 15: Cost Development Guidelines revisions that were developed in the CDS.

The committee endorsed the Manual 15 revisions by acclamation with 0 objections and 0 abstentions.

3. **Regional Transmission and Energy Scheduling Practices Revisions**

Chris Pacella provided an overview of revisions to the Regional Transmission and Energy Scheduling Practices document.

The committee endorsed the revisions to the Regional Transmission and Energy Scheduling Practices document by acclamation with 0 objections and 0 abstentions.

4. **RPM Capacity Transfer Rights**

Kevin Zemanek, Buckeye Power, reviewed the Buckeye proposal addressing RPM Capacity Transfer Rights.

The committee did not endorse the proposal with 55 (28%) in favor, 141 (72%) opposed, and 37 abstentions.

A second vote showed stakeholders did not prefer the proposal over status quo with 43 (23%) in favor, 144 (77%) opposed, and 46 abstentions.

5. **Undefined Regulation Mileage Ratio Calculation**

a) Michael Olaley reviewed the PJM proposal addressing Undefined Regulation Mileage Ratio Calculation.

b) Joe Bowring, IMM, reviewed the IMM proposal addressing Undefined Regulation Mileage Ratio Calculation.

The committee endorsed the PJM proposal with 152 (64%) in favor, 85 (36%) opposed, and 7 abstentions.

A second vote showed stakeholders preferred the PJM proposal over status quo with 147 (67%) in favor, 72 (33%) opposed, and 31 abstentions.

The committee did not endorse the IMM proposal with 100 (44%) in favor, 129 (56%) opposed, and 21 abstentions.

A second vote showed stakeholders did not prefer the IMM proposal over status quo with 102 (47%) in favor, 116 (53%) opposed, and 26 abstentions.

The PJM proposal moves to the Market and Reliability Committee (MRC) as the primary motion.

13. **Capacity Market Seller Offer Cap Order and Revised Auction Timelines**

Chen Lu provided an overview of the Capacity Market Seller Offer Cap order FERC recently issued in Docket Nos. EL-19-47, EL19-63 and ER21-2444. Pete Langbein presented and solicited feedback on draft timelines for the pre-auction activities for the upcoming December Base Residual Auction which are impacted by this order and the timing of the auction itself.

Pete noted that the posted materials contained incorrect information regarding auctions that will need to change if the BRA is delayed. The proposed delay in the BRA will not result in any delay to the capacity auctions getting back to the normal schedule.

A Post-Meeting version of the Proposed 23-24 BRA Auction Schedule has been posted to the meeting materials.
