Sean Flamm reviewed revisions to the allocation methodology for Schedule 9: PJM Settlement charges in Manual 27: Open Access Transmission Tariff Accounting. These revisions conform with the settlement agreement approved by the FERC in docket ER22-26 in November 2022.

**The committee endorsed the revisions by acclamation with 0 objections and 0 abstentions.**

### 3. Performance Impact of Multi-schedule Model in MCE on ECC Model Implementation (9:30 – 10:15)

- a. Keyur Patel reviewed the PJM options paper, Problem Statement and revised Issue Charge to address the performance impact of a multi-schedule model in the Market Clearing Engine (MCE) of the Enhanced Combined Cycle (ECC) and Energy Storage Resource (ESR) models as part of the Next Generation Energy Markets (nGEM) project.
- b. Catherine Tyler, IMM, provided comments on the PJM options paper and reviewed an alternate Issue Charge addressing this issue.

Both PJM and the IMM provided revisions to their Issue Charges. This item was delayed during the meeting to allow additional time for consideration. Discussions continued following Item 9.

**Paul Sotkiewicz, JPower, moved to defer the vote until the March MIC and Tom Hyzinski, GenON, seconded to the motion. The committee approved the motion with 60% in favor and 40% opposed.**
