Administration (9:00 – 9:05)

Amanda Martin reviewed the Antitrust, Code of Conduct, Public Meetings/Media Participation and the WebEx Participant Identification Requirements.

The Committee approved the draft minutes from the July 12, 2023 Market Implementation Committee by acclamation with 0 objections and 0 abstentions.

1. Amanda Martin reviewed the MIC Work Plan.

Endorsements/Approvals (9:05 – 10:50)

2. Capacity Offer Opportunities for Generation with Co-located Load (9:05 – 10:05)

Foluso Afelumo, PJM, led a discussion on packages in the matrix.

The committee did not endorse the following packages with supply from the system:

- The IMM Package with supply from the system with 50 (23%) in favor, 170 (77%) opposed, and 10 abstentions. A second vote showed stakeholders did not prefer the IMM Package over status quo with 50 (23%) in favor, 170 (77%) opposed, and 10 abstentions.
- The PJM Package with supply from the system with 33 (14%) in favor, 200 (86%) opposed, and 10 abstentions. A second vote showed stakeholders did not prefer the PJM Package over status quo with 20 (9%) in favor, 200 (91%) opposed, and 9 abstentions.
- The Exelon Package with supply from the system with 108 (49%) in favor, 112 (51%) opposed, and 10 abstentions. A second vote showed stakeholders did not prefer the Exelon Package over status quo with 109 (49%) in favor, 112 (51%) opposed, and 9 abstentions.

No package without supply from the system will move to the Markets and Reliability Committee (MRC).

The committee endorsed the Exelon Package without supply from the system with 103 (51%) in favor, 100 (49%) opposed, and 34 abstentions. A second vote showed stakeholders preferred the Exelon Package over status quo with 104 (51%) in favor, 99 (49%) opposed, and 49 abstentions.

The committee did not endorse the following packages without supply from the system:

- The Constellation Package without supply from the system with 74 (32%) in favor, 160 (68%) opposed, and 9 abstentions. A second vote showed stakeholders did not prefer the Constellation Package over status quo with 60 (27%) in favor, 160 (73%) opposed, and 10 abstentions.

- The IMM Package without supply from the system with 58 (27%) in favor, 160 (73%) opposed, and 4 abstentions. A second vote showed stakeholders did not prefer the IMM Package over status quo with 58 (27%) in favor, 160 (73%) opposed, and 12 abstentions.
- The PJM Package without supply from the system with 30 (14%) in favor, 188 (86%) opposed, and 12 abstentions. A second vote showed stakeholders did not prefer the PJM Package over status quo with 30 (14%) in favor, 188 (86%) opposed, and 12 abstentions.

The Exelon Package without supply from the system will move to the Markets and Reliability Committee (MRC) in September as the Main Motion.

3. [Reactive Supply and Voltage Compensation \(10:05 – 10:50\)](#)

Foluso Afelumo led a discussion on packages within the matrix.

The committee did not endorse the following packages:

- The Clean Energy Caucus Package with 179 (62%) in favor, 109 (38%) opposed, and 23 abstentions. A second vote showed stakeholders did not prefer the Clean Energy Caucus Package over status quo with 125 (44%) in favor, 157 (56%) opposed, and 17 abstentions.
- The PJM Package with 91 (33%) in favor, 185 (67%) opposed, and 14 abstentions. A second vote showed stakeholders did not prefer the PJM Package over status quo with 76 (30%) in favor, 173 (70%) opposed, and 29 abstentions.
- The IMM Package with 28 (10%) in favor, 247 (90%) opposed, and 12 abstentions. A second vote showed stakeholders did not prefer the IMM Package over status quo with 35 (12%) in favor, 251 (88%) opposed, and 5 abstentions.
- The IMM Flat Rate Package with 26 (9%) in favor, 251 (91%) opposed, and 12 abstentions. A second vote showed stakeholders did not prefer the IMM Flat Rate Package over status quo with 33 (11%) in favor, 260 (89) opposed, and 8 abstentions.

David Scarpignato, Calpine Energy Services, moved to sunset the Reactive Power Compensation Task Force, and John Horstmann, Dayton Power & Light Company, seconded the motion. The committee approved the motion by acclamation with 0 objections and 0 abstentions.

Members of the media are asked to announce their attendance at all PJM stakeholder meetings at the beginning of the meeting or at the point they join a meeting already in progress. Members of the Media are reminded that speakers at PJM meetings cannot be quoted without explicit permission from the speaker. PJM Members are reminded that “detailed transcriptional meeting notes” and white board notes from “brainstorming sessions” shall not be disseminated. Stakeholders are also not allowed to create audio, video or online recordings of PJM meetings. PJM may create audio, video or online recordings of stakeholder meetings for internal and training purposes, and your participation at such meetings indicates your consent to the same.

Participant Identification in Webex:

When logging into the Webex desktop client, please enter your real first and last name as well as a valid email address. Be sure to select the “call me” option. PJM support staff continuously monitors Webex connections during stakeholder meetings. Anonymous users or those using false usernames or emails will be dropped from the teleconference.

Participant Use of Webex Chat:

The use of the Webex chat feature during meetings shall be primarily reserved for administrative and logistical purposes, such as managing a question or comment queue, noting technical difficulties, and meeting support or management purposes. Utilizing Webex chat for any other commentary should be limited to short phrases. Detailed commentary or substantive dialog shall be shared orally by entering the speaker queue.
