ADMINISTRATION

Mr. Kormos welcomed stakeholders to the meeting and Mr. Anders provided the Anti-trust and Code of Conduct announcements. Mr. Kormos congratulated Mr. Griffiths for his recent appointment as Executive Director of the Consumer Advocates of PJM States (CAPS). Mr. Griffiths discussed the role of CAPS.

ENDORSEMENTS/APPROVALS

1. ADMINISTRATION

Minutes of the August 29, 2013 Markets and Reliability Committee (MRC) meeting were **approved** by acclamation with no objections or abstentions.

2. PJM MANUALS

- A. Mr. Hauske presented revisions to Manual 27: OATT Accounting and Manual 12: Energy and Ancillary Market Operations.
- B. Mr. Smart provided an update on changes to Manual 01: Control Center and Data Exchange Requirements.

Following discussion, items 2.A and B were **endorsed** by acclamation with no objections or abstentions.

3. COORDINATED TRANSACTION SCHEDULING

Ms. Carroll presented the proposed NYISO–PJM coordinated transaction scheduling product. Members discussed credit requirements and implementation plans, including the second implementation timing vote to be taken at least two months prior to implementation. Following discussion, the proposed manual, Operating Agreement (OA) and Tariff revisions were **endorsed** by acclamation with four objections and 31 abstentions.

4. SYNCHRONIZED RESERVE (SR) PERFORMANCE

Mr. Bresler reviewed the Tier 2 SR Performance Penalty proposals, noting that Proposal B had received the highest support at the Operating Committee (OC). Mr. Pratzon noted that at the OC meeting on September 23, 2013, Tier 2 resource providers and PJM committed to work together to improve performance of Tier 2 resources when called. Mr. Schofield discussed Proposal C and moved it as an alternate motion. Following discussion, the main motion, Proposal B as endorsed by the OC including manual, OA and Tariff revisions, was **endorsed** in a sector-weighted vote with 3.6 in favor.

5. CAPACITY CREDIT CALCULATION FOR WIND RESOURCES

Mr. Falin discussed proposed changes to the treatment of curtailed hours in the wind capacity credit calculation, noting that Alternative 2 had received the highest support at the Planning Committee (PC) and was therefore the main motion. Following discussion, the main motion, including proposed manual revisions, was **endorsed** by acclamation with five objections and 18 abstentions.

6. EFFICIENCY OF DEMAND RESPONSE REGISTRATION PROCESS

Mr. Langbein presented proposed solutions to remove or modify the Load Serving Entity role from the emergency and economic registration review process. Following discussion, the proposed manual, OA and Tariff revisions were **endorsed** by acclamation with one objection and one abstention.



7. ENERGY MARKET UP-LIFT SENIOR TASK FORCE (EMUSTF) CHARTER

Mr. Anders presented the draft EMUSTF charter. Following discussion, the proposed charter was **approved** by acclamation with no objections or abstentions.

8. ENERGY STORAGE RESOURCES

Ms. Dudley, Demansys, presented an updated proposed problem statement and issue charge regarding allowing advanced energy storage resources to participate in capacity auctions. She discussed incorporation of a friendly amendment to eliminate the restriction to discussion of only “advanced” energy storage resources from the problem statement. Following discussion, the stakeholder group assignment was changed to the Planning Committee, and the proposed amended problem statement and amended issue charge were **approved** by acclamation with two objections and 18 abstentions.

FIRST READINGS

9. MAXIMUM IMPORT LEVEL

Mr. Bresler discussed the concept of developing a Maximum Capacity Import Level and implementation of an RTO import limit in RPM planning parameters. The committee will be asked to endorse a proposal at a future meeting.

10. MEMBERS COMMUNICATION

This item was deferred to a future meeting.

11. 2013 IRM STUDY

Mr. Falin reviewed the preliminary results of the 2013 IRM Study. The committee will be asked to endorse the results of the study at its next meeting.

12. PJM MANUALS

- A. Ms. Reiter reviewed changes to Manual 03: Transmission Operations. The committee will be asked to endorse these changes at its next meeting.
- B. Mr. Bryson reviewed changes to Manual 13: Emergency Procedures. The committee will be asked to endorse these changes at its next meeting.
- C. Mr. Schweizer reviewed changes to Manual 10: Pre-Scheduling Operations. The committee will be asked to endorse these changes at its next meeting.
- D. Mr. Schweizer reviewed changes to Manual 14D: Generator Operational Requirements. The committee will be asked to endorse these changes at its next meeting.
- E. Mr. McGlynn reviewed draft changes to PJM’s Manual 14B regarding the 2 year planning representation of the short circuit base case. The committee will be asked to endorse the revisions at its next meeting.

FUTURE AGENDA ITEMS
