ADMINISTRATION

Mr. Kormos welcomed stakeholders to the meeting and Ms. Ford provided the Anti-trust and Code of Conduct announcements.

ENDORSEMENTS/APPROVALS

1. DRAFT MINUTES

Minutes of the April 24, 2014 Markets and Reliability Committee (MRC) meeting were <u>approved</u> by acclamation with no objections or abstentions with the addition of Mr. Singh as a participant.

2. PJM MANUALS

- A. Mr. Boyle reviewed changes to Manual 36: System Restoration.
- B. Mr. Reiter reviewed changes to Manual 03: Transmission Operations.
- C. Ms. Coyne presented proposed revisions to Manual 28: Operating Agreement Accounting regarding provisions of additional details and cleanup items.
- D. Mr. Langbein presented proposed Manual 18: PJM Capacity Market revisions developed by the Demand Response Subcommittee that would allow a curtailment service provider to add additional MWs as "existing" for offer into RPM auction through an exception process if the nominated amount on the registration is low because the peak load contribution is low due to a load data anomaly.
- E. Ms. Souder presented conforming revisions to Manual 33: Administrative Services for the PJM Interconnection Operating Agreement to incorporate communications surrounding load reallocation due to member default.
- F. Mr. Langbein presented proposed revisions for DR Operational Enhancements to Manuals 11: Energy & Ancillary Services Market Operations, 13: Emergency Operations, 18: PJM Capacity Market, 19: Load Forecasting and Analysis, and 28: Operating Agreement Accounting. The proposed revisions to sections of Manual 18 related to small commercial demand response were deferred from consideration at this time.
- G. Mr. Souder presented revisions to the PJM Regional Practices in compliance with the recent FERC order related to Variable Energy Resources.

Following discussion, the proposed revisions in items 2.A through 2.G (including the modification nto item 2.F) were **endorsed** by acclamation with no objections and one abstention.

3. REGIONIAL PLANNING PROCESS SENIOR TASK FORCE (RPPTF)

Mr. Barrett presented proposed Operating Agreement (OA) and Tariff revisions related to the Multi-Driver Approach developed by the RPPTF. Following discussion, the proposed revisions were <u>endorsed</u> by acclamation with one objection and three abstentions.

4. FREQUENTLY MITIGATED UNITS (FMU)

Mr. Zadlo presented proposed adjustments to the FMU provisions. Following discussion, the main motion (represented as package G) <u>failed</u> in a sector-weighted vote with 1.99 in favor. The first alternate motion (package H) also <u>failed</u> in a sector-weighted vote with 2.65 in favor. The second alternate motion (package F') also <u>failed</u> in a sector-weighted vote with 1.62 in favor. Ms. Bruce moved and Mr. Griffiths seconded package A. Package A was <u>endorsed</u> in a sector-weighted vote with 3.46 in favor.

5. <u>ENERGY AND RESERVES PRICING AND INTERCHANGE VOLATILITY (ERPIV)</u>

Ms. Morelli presented a proposal developed during special sessions of the Market Implementation Committee (MIC) related to short term solutions to Energy and Reserves Pricing. PJM reaffirmed their commitment to provide an update after a few months of operation. Following discussion, the proposed revisions <u>failed</u> in a sector-weighted vote



with 2.21 in favor

Mr. Scarpignato moved and Ms. Bruce seconded the following:

- PJM package be endorsed with a sunset of September 30, 2014.
- A long-term solution being developed such that it can be filed at FERC no later than October 1, 2014.
- Stakeholders encourage the Board to file at FERC under Section 205 or 206, as appropriate, or take whatever action is deemed appropriate.
- The long-term solution should be implemented as soon as technically feasible with a desired target of January 1, 2015.

The alternate motion was endorsed by a sector-weighted vote with 4.71 in favor.

6. AUCTION SPECIFIC TRANSACTIONS IN RPM

Mr. Trayers, Citigroup Energy Inc., presented a problem statement regarding changes to the submission date of Auction Specific Transactions in RPM. Mr. Trayers moved and Mr. O'Connell seconded that the solution be approved directly without action on the problem statement. Following discussion, the motion was withdrawn. Following further discussion, the proposed problem statement was <u>endorsed</u> by acclamation with no objections or abstentions and was referred to the MIC for review of the proposed solution.

7. REVISIONS TO DEFINITION OF ZONAL BASE LOAD (OA 1.3.39)

Mr. Horger presented revisions to the definition of zonal base load. Following discussion, the proposed revisions were **endorsed** by acclamation with no objections and one abstention.

8. FTR MARKET ENHANCEMENTS

Mr. Ott presented a proposed problem statement and issue charge related to FTR market enhancements. The middle column of the problem statement was corrected to be labeled "adequacy" percentage, and the first key work activity of the issue charge was replaced with "Provide education regarding derivations of underfunding and discuss as appropriate which could result in expansion of items in scope." Following discussion, the proposed problem statement and issue charge were approved by acclamation with two objections and no abstentions.

FIRST READINGS

9. QUALIFYING TRANSMISSION UPGRADE (QTU) CREDIT REQUIREMENT SCOPE

Ms. Ford provided feedback from the MIC regarding scope of the issue charge. In particular, the discussion was regarding whether the scope includes a review of various mechanisms for QTUs to replace capacity commitments. It was agreed that the scope should be clearly defined by the MIC to include replacement capacity mechanisms.

10. MOPR UNIT SPECIFIC REVIEW

Mr. Baker presented a proposal related to the MOPR Unit Specific Review developed by the Capacity Senior Task Force. Mr. Carretta, PSEG, provided an overview of alternate Package D. The committee will be asked to endorse the proposal at its next meeting.

11. RPM SUPPLY CURVE TRANSPARENCY

Mr. Thomas Zadlo presented packages resulting from the MIC working session discussions. The committee will be asked to vote on packages at the June MIC.



12. GAS-FIRED UNIT COMMITMENT COORDINATION

Mr. Bryson presented a proposed problem statement and issue charge related to unit commitment practices for gasfired generation units. The following friendly amendments were made:

- The Stakeholder Group Assignment was replaced with:
 - The issue will be addressed at the Operating Committee (OC) with assistance from the Market Implementation Committee (MIC) as appropriate. The approval authority will ultimately rest with the Markets and Reliability Committee (MRC).
- The following Key Work Activity was amended to include the parenthetical in the next bullet:
 - "Firmness" of PJM operator unit commitment decisions outside of DA market (focus on communications)
- The following new Key Work Activities were added:
 - Dual fuel tracking and considerations
 - o How the following are defined and considered:
 - Economic versus reliability outages
 - EFORp
 - Tools to manage limited availability and unit flexibility parameters

Mr. Tatum moved, and Ms. Riding seconded, a motion to approve the problem statement and issue charge, as amended above. Following discussion, the problem statement and issue charge were <u>approved</u>, as amended, by acclamation with no objection and four abstentions.

13. ENERGY AND RESERVE MARKET EFFICIENCY

Mr. Keech presented a proposed problem statement and issue charge related to Energy and Reserve Market Efficiency. A friendly amendment was made to include the problem statement and issue charge in the ERPIV charter. The committee **approved** the charter revision by acclamation with no objections and one abstention.

14. <u>FORWARD PRICE PROJECTION PERFORMANCE</u>

Ms. Rebecca Carroll provided an update on PJM's efforts around the transparency and accuracy of IT SCED forward price projections.

15. <u>SPS PRESENTATIONS</u>

Mr. Kormos presented removal of the Conemaugh #2 Stability Trip Special Protection Scheme.

16. PJM MANUALS

- A. Ms. Huang was available for questions regarding revisions to Manual 01: Control Center and Data Exchange Requirements and Manual 14D: Generator Operational Requirements regarding PMU and new Generation Interconnection. The committee will be asked to endorse these revisions at its next meeting.
- B. Mr. McCartha was available for questions regarding revisions to Manual 01: Control Center and Data Exchange Requirements and Manual 14D: Generator Operational Requirements regarding PJMnet. The committee will be asked to endorse these revisions at its next meeting.

17. <u>DESIGNATED ENTITY AND INTERCONNECTION COORDINATION AGREEMENTS</u>

Mr. Barrett presented the proposed draft Designated Entity Agreement (DEA) and Interconnection Coordination



Agreement (ICA) developed by the RPPTF and relating to FERC Order No. 1000 window proposal process. He noted that to comply with FERC order, the DEA must be filed prior to July 14, 2014.

INFORMATIONAL ITEMS

18. COLD WEATHER OPERATIONS

Mr. Kormos was available and took questions regarding the Cold Weather Operations Report and its key recommendations.

19. RPM AUCTION RESULTS

Mr. Ott was available and took questions regarding the results of the recently completed Base Residual Auction.

20. US COURT OF APPEALS DECISION ON FERC ORDER 745

Ms. Hugee was available and took questions on the recent decision by the US Court of Appeals regarding FERC Order 745.
