Administration (9:00-9:05)

Ms. Suzanne Daugherty and Mr. Dave Anders welcomed the participants, and provided the antitrust and code of conduct announcements.

Endorsements/Approvals (9:05-10:15)

1. <u>Draft Minutes (9:05-9:10)</u>

Minutes of the January 25, 2018 meeting of the Markets and Reliability Committee (MRC) were **approved** by acclamation with no objections or abstentions.

2. PJM Manuals (9:10-9:30)

- A. Mr. Jeff McLaughlin presented proposed revisions to PJM Manual 2: Transmission Service Request. These changes correspond to Tariff revisions endorsed by the MRC at its December 21, 2017 meeting.
- B. Mr. Rami Dirani presented conforming revisions to Manual 11: Energy & Ancillary Services Market Operations to clarify the Energy Offer Verification process.
- C. Ms. Rebecca Stadelmeyer presented proposed revisions to Manual 14D: Generator Operational Requirements regarding information requirements for generation transfers. Mr. Bob O'Connell moved and Mr. John Brodbeck seconded deferring voting on the proposed Manual 14D revisions and remanding the proposed revisions to the Operating Committee for additional consideration. The motion to defer and remand was **approved** by acclamation with no objections or abstentions.
- D. Ms. Terri Esterly presented proposed revisions to Manual 18: PJM Capacity Market regarding external capacity enhancements.

Following discussion, the proposed manual revisions in items 2A, B and D were <u>endorsed</u> by acclamation with no objections or abstentions.

3. Tariff Revisions to Address Overlapping Congestion (9:30-9:45)

Mr. Tim Horger presented proposed Tariff and Operating Agreement (OA) revisions to address overlapping congestion. Mr. Steve Lieberman moved and Mr. Carl Johnson seconded deferring voting on the proposed revisions to the March 22, 2018 MRC meeting, and (should the MRC endorse the proposed revisions) to request voting on the proposed revisions at the March 22, 2018 Members Committee meeting. Following discussion, the motion to defer was approved by acclamation with no objections or abstentions.





4. Summer-Only Demand Response Sr. Task Force Charter (SODRSTF) (9:45-9:55)

Ms. Becky Carroll presented a draft charter for the SODRSTF. Following discussion, the proposed charter was **approved** by acclamation with no objections or abstentions.

5. Sunsetting Sr. Task Forces (9:55-10:15)

Ms. Becky Carroll discussed sunsetting the Underperformance Risk Management Sr. Task Force (URMSTF), and Mr. Dave Anders discussed sunsetting the Regulation Market Issues Sr. Task Force (RMISTF). Following discussion, sunsetting the two task forces was **approved** by acclamation with no objections or abstentions.

6. Energy Price Formation Sr. Task Force (EPFSTF) (10:15-10:30)

Mr. Dave Anders presented a draft charter for the EPFSTF. The committee will be asked to approve the proposed charter at its next meeting.

7. PJM Manuals (10:30-11:00)

- A. Ms. Bilge Derin reviewed proposed revisions to Manual 01: Control Center and Data Exchange Requirements. The committee will be asked to endorse the manual revisions at its next meeting.
- B. Mr. Andy Ford reviewed proposed revisions to Manual 3A: Energy Management System (EMS) Model Updates and Quality Assurance (QA). The committee will be asked to endorse the manual revisions at its next meeting.
- C. Mr. Ed Franks presented proposed revisions to Manual 14A: New Services Request Process and Manual 14E: Additional Information for Upgrade and Transmission Interconnection Projects. These changes correspond to the Tariff revisions endorsed by the MRC at its December 21, 2017 meeting. The committee will be asked to endorse the manual revisions at its next meeting.
- D. Ms. Becky Carroll presented proposed revisions to Manual 33: Administrative Services for PJM Interconnection Agreement. The committee will be asked to endorse the manual revisions at its next meeting.
- E. Mr. Donnie Bielak reviewed proposed revisions to Manual 37: Reliability Coordination. The committee will be asked to endorse the manual revisions at its next meeting.

Informational Updates (11:00-12:00)

8. Incremental Auction Sr. Task Force (IASTF) (11:00-11:15)

Mr. Brian Chmielewski provided an update on the work of the IASTF, indicating that the IASTF recommended placing their work on hiatus until the FERC acts on the IASTF's Phase 1 solution.

9. Special Protection Systems (SPS) / Remedial Action Schemes (RAS) (11:15-11:30)





Mr. Alan Engelmann, ComEd, discussed removal of SPS/RAS at University Park North and Davis Creek.

10. Competitive Planning Process Cost Containment (11:30-11:45)

Ms. Janell Fabiano provided an update on the Special Planning Committee sessions regarding Competitive Planning Process Cost Containment.

11. Update on Previously Endorsed OA Revisions (11:45-12:00)

Ms. Sue Glatz and Ms. Pauline Foley provided an update on previously endorsed administrative revisions to the OA related to Order 1000.

FERC Order in Dockets ER18-88-000 and ER18-88-001

Mr. Adam Keech discussed the recently received FERC order regarding limiting eligible bidding points for virtual transactions. Specifically, he addressed the implementation timing, and indicated that PJM is evaluating how to address the ordered January 16, 2018 implementation date.

Ohio Valley Electric Cooperative (OVEC) Integration

Ms. Suzanne Daugherty confirmed that FERC had approved OVEC's integration into PJM and provided notice that the OVEC Board approved integration into PJM with effective date of June 1, 2018 instead of the previously expected March 1, 2018 implementation date.

Five Minute Settlements

Ms. Suzanne Daugherty provided notice that PJM received an order from FERC approving PJM's filing regarding five minute settlements with an April 1, 2018 implementation date with a few compliance requirements that, based on initial review, PJM does not expect will affect the April 1, 2018 implementation date.

Show Cause Order Regarding Supplemental Projects

Mr. Steve Herling provided an update on the recently received FERC order in the Show Cause proceeding regarding supplemental projects, including the planned compliance filing. He indicated that PJM will be providing input to the Transmission Owners related to the clarifications to the process structure required in the compliance filing.

FERC Rulemaking Regarding Energy Storage Resources

Ms. Jennifer Tribulski provided an update regarding the recently received FERC rulemaking regarding Energy Storage Resources, including planned discussion and input to PJM's compliance filing in special sessions of the Market Implementation Committee.





FERC Rulemaking Regarding Primary Frequency Response

Mr. Dave Souder provided an update the recently received FERC rulemaking regarding primary frequency response. He indicated that the order applies to new resources, and that the Primary Frequency Response Sr. Task Force will continue to address solutions for existing resources.
