  - Acceptance of Construction Responsibility;
  - Status change from Engineering & Procurement to Under Construction; and
  - Status change to In-Service.

#### New Section 6.2.1.1 Supplemental Cost Tracking

- Project updates including engineering progress, cost estimates, and construction updates shall be reported as part of the regular status updates. At a minimum the TO shall provide updates to PJM, as needed, for the following project status updates and milestones or acknowledge that the current estimate is accurate:
  - Posting of the Local Plan
  - Status change from Engineering & Procurement to Under Construction; and
  - Status change to In-Service
