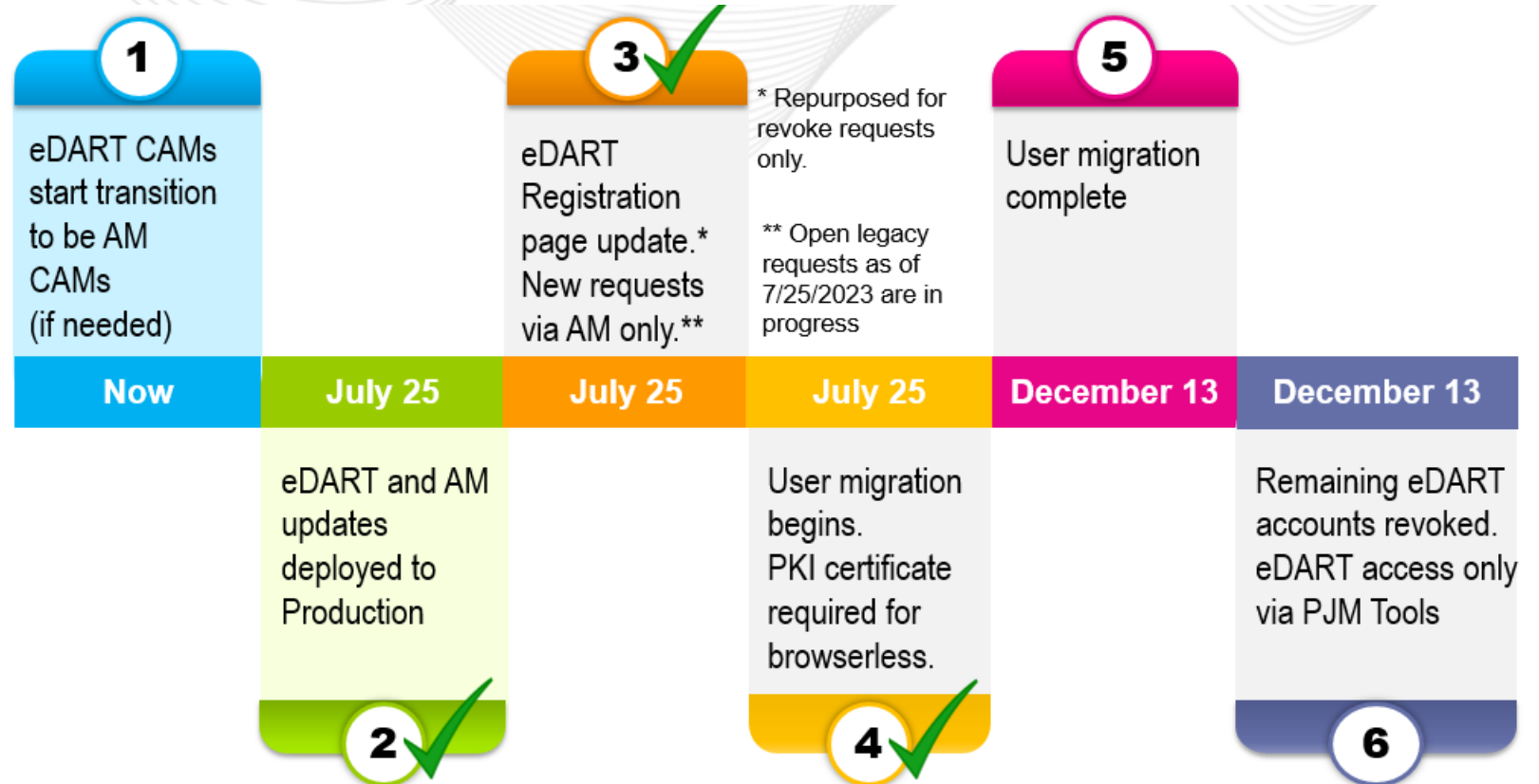
With the ongoing eDART refresh, management of eDART accounts will be handled exclusively in Account Manager:

- New user account creation
- Granting eDART access to existing user accounts
- Password resets
- Unlocking accounts
- Terminating eDART access
