Susan McGill reviewed the proposed sunset of the EGCSTF and draft charter for a new Electric Gas Coordination Subcommittee (EGCS). Following discussion, the committee **approved** sunsetting the EGCSTF and establishing the EGCS by acclamation with no objections or abstentions.

### 2. Hourly Notification Times

Joe Ciabattoni reviewed a proposed solution and corresponding Tariff, Operating Agreement (OA), and Manual 11: Energy & Ancillary Services Market Operations revisions to allow for hourly notification times to be considered when clearing the Day-Ahead Energy Market. Following discussion, the proposed solution and associated Tariff, OA and Manual 11 revisions were **endorsed** by acclamation with no objections or abstentions. Lisa Drauschak noted that same day endorsement would be sought at the Members Committee (MC); there were no objections to placing this item on the Consent Agenda for that meeting.

A. Eliseo Carrasco reviewed proposed revisions to Manual 03A: EMS Model Updates & Quality Assurance resulting from its periodic review. The committee will be asked to endorse the proposed Manual 03 revisions at its next meeting.

B. Augustine Caven reviewed proposed revisions to Manual 14F: Competitive Planning Process resulting from its periodic review. The committee will be asked to endorse the proposed Manual 14F revisions at its next meeting.

C. Josh Bruno reviewed proposed revisions to Manual 21B: PJM Rules and Procedures for Determination of Generating Capability conforming to FERC approved Reliability Assurance Agreement (RAA) definitions for “Gas Combined Cycle Dual Fuel Class” and “Gas Combustion Turbine Dual Fuel Class”.
