<b>Reason for change:</b>	

Develop fuel assurance business rules to mitigate the impact of non-fuel assured Black Start resources being unavailable during a restoration event due to fuel unavailability.

**Summary of the changes:**

- M12: Changes to incorporate black start fuel assurance into the PJM black start requirements and obligations, restoration assumptions, definitions, GO commitment, performance standards, testing and training,
- M14D: Changes to incorporate black start fuel assurance into the black start generation procurement process
- M27: Changes to incorporate black start fuel assurance into the black start service credits and accounting
- M36: Changes to add the zonal minimum black start fuel assurance criteria and zonal reliability analysis criteria to the minimum critical black start requirement
