1. PJM reviewed the Anti-trust, Code of Conduct, Public Meetings/Media Participation, and Identification Requirement guidelines. The draft minutes from the March 3 meeting were approved by acclamation.

- 2. Mr. Dave Souder, PJM, provided an update on Docket ER20-841-000, in which FERC accepted the PJM Transmission Owner's proposed Tariff, Attachment M-4 revisions, effective March 17, 2020.
- 3. Mr. Erik Heinle, Office of People's Council for the District of Columbia, and Mr. Greg Poulos, Consumer Advocates of the PJM States, provided an update on the first component of this issue's scope: defining criteria for mitigating existing CMP's. The group offered both support and opposition for continuing to discuss the *mitigation* component.
