## Administration (9:00 – 9:15)

1. Dave Souder, PJM, called the meeting to order. Molly Mooney, PJM, reviewed the Antitrust, Code of Conduct, media participation, and WebEx guidelines. The committee will be using the voting application for all endorsement items at the July meeting.

Dave Souder discussed a concern raised by members regarding conduct within the stakeholder process. Dave Souder reminded stakeholders to ensure comments are respectful and succinct so that we are all mindful of everyone's time and to ensure PJM can conduct an effective stakeholder process.

2. Molly Mooney reviewed the July 13, 2021 Planning Committee Agenda. No changes to the agenda were requested.
3. Molly Mooney reviewed the draft June 8, 2021 Planning Committee meeting minutes and the committee approved the minutes.
4. Molly Mooney reviewed the 2021 Planning Committee Work Plan.

## Endorsements (9:15 – 9:45)

5. Manual 14A: New Services Request Process Update  
Onyinye Caven, PJM, provided a review of conforming Manual 14A language for the quick fix of close of queue date and application review timing changes. **The committee endorsed the manual changes with 95% support. There were 154 Yes votes, 8 No votes, and 3 Abstain.**
6. Critical Infrastructure Stakeholder Oversight - Mitigation  
Michael Herman, PJM, reviewed the Operating Agreement language associated with the approved Mitigation package. **The committee voted to affirm the amended draft Operating Agreement revisions accurately reflects the CISO Mitigation package (as contained in the matrix) which was endorsed by the PC at its February 2021 meeting. This affirmation vote passed with 87% support. There were 134 Yes votes, 20 No votes, and 28 Abstain.**

Patricio Rocha-Garrido, PJM, provided a first read of a cover to cover review of Manual 20. The committee will be asked to vote on the manual changes at the August meeting.
