- In 2018, PJM implemented whitelist feature which enables CAMs to enter associated email addresses or particular domains for the accounts they manage.
- Adding the whitelist entries to accounts better secures access to accounts by preventing users with invalid email domain names from requesting access.
- Utilizing the whitelist feature as a first step will assist CAMs with the validation of all account users as a part of the user recertification process.

- For security reasons, PJM is requiring that all accounts have a whitelist entry in Account Manager by June 30.
- CAMs will see information about this in Account Manager.

Account Manager Enhancements Release

- Whitelist Pop-Up Reminder
 - Upon log-in to Account Manager, CAMs will be reminded to populate whitelists for the accounts they manage that have no domains or email addresses whitelisted
- Email validation for new user creation
 - If a person attempts to create a new user account, with an email that is associated with an existing user account, the person will not be able to proceed in the creation of that user account.
- Release information
 - Train release on June 22
 - Production release in July

[Account Manager](#) is used to create accounts and request and grant access to PJM's tools and website.

Key Product Features

- Grants access to PJM Tools
- Member CAM's can determine and regulate access for their respective companies

[Bulletin Board](#) facilitates power contracting activity.

Key Product Features

- Provides users with access to a larger pool of buyers and sellers of contracts for electric power
- Allows users to view, post and modify requests to buy or offers to sell power

[Data Viewer](#) allows users to view operational and market data graphically.

Key Product Features

- Display real-time LMPs, IT SCED forecasted LMPs, Dispatch Rate, etc.
- Customizable data plots and graphs

[eDataFeed](#) is a web service that allows subscribers to select and “stream” PJM locational marginal price data, as well as some operational data directly into their system. eDataFeed delivers information in a format called Simple Object Access Protocol (SOAP) that enables data capture, analysis and decision support to meet the trading, risk management and business decisions of PJM’s members (customers).

Key Product Features

- Allows for automated data retrieval

[Messages](#) provides updates and important messages regarding PJM tools.

Key Product Features

- Used by members to view updates and important messages regarding PJM tools

[Resource Tracker](#) provides generation owners a single view of generator ownership information as recorded across various PJM applications.

Key Product Features

- Single point mechanism for generator ownership information
 - Ownership changes
 - Energy, Capacity and Ancillary Service Ownership
 - Marketing Company
 - Dispatching Company
- Annual confirmation period
