## Background

- The Reserves project was approved by FERC on Sep.1 for a go-live date of Oct. 1

## The work described in the filing includes:

- Consolidation of Tier 1 and Tier 2 synchronized reserves
- Reserves alignment between the Realtime and Day Ahead markets. Including in both:
  - 10 minute reserves
  - 30 minute reserves
- Flexible subzones
