RE: Motion of Illinois Industrial Energy Consumers to Intervene

Dear Secretary Perry, Asst. Secretary Walker and Deputy Asst. Secretary Jereza:

Attached is the Illinois Industrial Energy Consumers (“IIEC”) Motion to Intervene in the proceeding concern FirstEnergy Solutions Corp.’s (“FES”), Request for Emergency Action Under Section 202(c) of the Federal Power Act. IIEC is comprised of several of the largest manufacturers in the United States, with significant electricity-consuming facilities in the service territory of Commonwealth Edison Company, a public utility in Illinois, and a member of PJM. IIEC member companies strongly oppose the FES Request for Emergency Action. If the Request is not denied outright, all interested parties should be given sixty (60) days to file Comments, as requested by the Electric Power Supply Association and other organizations on Friday, March 30, 2018.
