- The most recent tests occurred on:

- July 10 for PECO and DPL (PRD only) zones
- July 11 for DAY and COMED (Summer Only) zones

- Next steps:

- Retest process (if desired)
- Test Emergency Energy Settlements
- Compliance

- Retest (if desired) – can only be determine performance once all registrations in zone are tested (annual + summer only):
  - If test reductions  $> 75\%$  of commitment, CSP can self schedule retest(s) in DR Hub (must be in same season)
  - If test reductions  $\leq 75\%$  of commitment, CSP has 46 days from the test date to request that PJM schedule a single retest
    - PECO and DPL (PRD only) zones – by August 25, 2024
    - DAY and COMED (Summer Only) zones – August 26, 2024

- Submit test **energy settlements** within 60 days of test event
  - PECO zone – by September 8, 2024
  - DAY and COMED (Summer Only) zones – by September 9, 2024
- CBLs
  - Generally, for PECO tests, CSP will need to upload 24 hours of daily load data for the following dates to calculate the *3 Day Types with SAA CBL*:
    - **July 2, 3, 5, 8, 9, 2024**
  - Generally, for DAY and COMED (Summer Only) tests, CSP will need to upload 24 hours of daily load data for the following dates to calculate the *3 Day Types with SAA CBL*:
    - **July 3, 5, 8, 9, 10, 2024**

- CSP Retest (initial test > 75%)
  - Start/end instructions sent from DR Hub in response to normal CSP polling according to registrations' lead time
  - Email sent at notification time
- PJM Retest (initial test <= 75%)
  - Day Before PJM Retest Date:
    - Load Management/PRD Retest Summary event(s) posted to DR Hub Events section by 10:00 EPT the day before retest date
      - CSP should monitor DR Hub webpage and/or use web service function to obtain retest date
      - Since retests are CSP specific they are not posted to the Test webpage
    - Email sent by 10:00 EPT the day before retest date
  - Event Day
    - Start/end instructions sent from DR Hub in response to normal CSP polling according to registrations' lead time
    - Email sent at notification time

- Compliance will be determined after the Delivery Year
- Only registrations that have not been part of a Load Management Event during the DY will be subject to capability demonstration by test

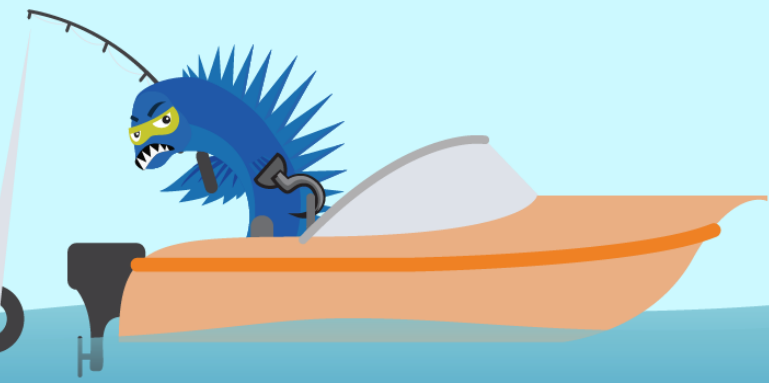
