Administration

- Introductions and roll call conducted in room and for those attending via WebEx/Teleconference.
- Draft Agenda approved; Meeting Notes from 9/19/2018 meeting approved.

Manual 01, Section 3.3

- Ms. Suzie Fahr shared the current text in Manual 01, Section 3.3 - Synchrophasor Data Exchange. This is an area where change is proposed to more clearly outline/update data quality thresholds. Ms. Fahr proposed dividing up the requirements into the following areas: Accuracy, Availability, Latency, and Good Samples, and the group unanimously supported this proposal. Mr. Erkan Tuna clarified bad vs. good data. Mr. Shaun Murphy noted that status codes address at device level, while accuracy is measured at individual signal level. Ms. Fahr will work to have a draft available for all to review at the next meeting in November.

Group Discussion Topics

- **What DQ issues have you seen, and how have you worked to address them?**
 - Adam Veno (AEP) noted PMUs are deployed with no consideration of bandwidth and priority of other protocols.
 - Harry Grewal (FE) offered there is no dedicated tech support, per se.
 - Bob Barth (DEOK) addressed separation of control-based devices from others – some units report data as bad with loss of voltage instead of '0'.
- **Use of PMU data in Operations? Barriers?**
 - Harry Grewal (FE) advised FE is not using PMU data.
 - Bob Barth (DEOK) advised Duke is down-sampling and testing it.
- **PMU Installations – Updates at your company?**
 - Drew Trump (PPL) reported no PPL apps are using PMU data, and there is no commitment to install (no use identified to date).
 - David Schooley (ComEd) reported that new installs are underway (eight due in November 2018, more expected in 2019); ComEd is using same apps as PJM (RTDMS, etc.). Mr. Grytsulyak followed up on oscillation reported by Mr. Schooley, and Mr. Schooley provided details on when this event occurred (~1kV dip on 10/16/2018, occurring over a 1 hr. period (eta 15:49 (EDT))).

Mr. Shaun Murphy mentioned upcoming NASI Meeting in Philadelphia, PA next week. Meeting materials are posted online and all encouraged to check them out.
