#### PJM Restoration Drill Update

- The 2020 Spring Restoration drill scheduled for May has been cancelled
- For 2020, the fall individual TO restoration drills will be replaced with two remote drills to be scheduled between September 29th and November 4th

- The drills will be generally split between eastern and western companies, with details as to which drill each company will be participating to be communicated at a later time
- Specific dates for the drill exercises will be scheduled as soon as conditions allow them to be accurately determined
- Invitations for the 2020 Restoration Drills will be distributed to TOs and GOs closer to the exercise dates
- PJM will keep a record of all injects submitted thus far and will be able to use these in the new drill that corresponds to your area. As we get closer to the fall drills, if you'd like to add, change or remove any of those injects, please let us know.
- This drill schedule is for 2020 only. PJM will resume holding a system-wide drill in the spring and individual TO drills in the fall of 2021 and beyond.
