

Interconnection Projects

- Changes must be approved in Queue Point by June 30th
- Developers are encouraged to notify their PJM PM of any changes to the point of contact or Interconnection Customer name
- All active projects in the AE1-AG1 queue that are subject to the transition requirements will receive an email prior to the transition date.
- Prior to the transition date, enhancements will be made to Queue Point to facilitate the collection of Readiness documents and New Service Requests

 - Provide to SystemPlanning.Admin@pjm.com with the queue number in the subject line

- Developers must click Submit to complete the submission process. Drafts will not be reviewed.
- A confirmation email will be sent upon submission. Contact the PJM PM if a confirmation email is not received.

Application and Studies Agreement (ASA)

An Application and Studies Agreement must be submitted for the following requests:

- Generator Interconnections Requests to interconnect a new generation facility or to increase the capacity of an existing generation facility interconnected with the Transmission System in the PJM region, or Interconnect a generating unit to distribution facilities located in the PJM Region that are used to make wholesale sales using the output of the generating unit.
- Transmission Interconnection Requests to interconnect or add new Merchant Transmission Facilities to the Transmission System or increase the capacity of existing Merchant Transmission Facilities interconnected with the Transmission System.
- Long Term Firm Transmission Service for a period extending beyond the 18 month Available Transmission Capacity horizon.

- Fund Network Upgrades and seek certain Incremental Auction Revenue Rights
- Upgrade facilities or advance already-identified upgrades

Surplus Interconnection Service Study Agreement (SISA)


Surplus Interconnection Service refers to any unneeded portion of the Interconnection Service established in a Generation Interconnection Agreement, such that if the service is used, the total amount of Interconnection Service at the Point of Interconnection would remain the same. Surplus Interconnection Service requests can be made by an existing Project Developer whose Generating Facility is already interconnected to the PJM transmission system, one of its affiliates, or by an unaffiliated that submits a Surplus Interconnection Request to utilize Surplus Interconnection Service within the Transmission System in the PJM Region.
