## Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct and Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the June 15, 2017 MSS meeting.

Members were asked to provide any updates to their NSPL scaling plans. No updates were provided.

## Working Issues

### 1. FERC Order 825 – Discussion on Sub-Hourly Settlements

Mr. Sean Flamm, PJM, provided an update and examples on the MSRS Report format for interval ending columns. PJM will continue to communicate all report documentation updates to the Market Settlements Subcommittee distribution list.

Mr. Ray Fernandez, PJM, provided clarification on Real-time and Day-Ahead LMP postings on [pjm.com](http://pjm.com) and Data Miner 2. Data Miner 2 will begin to provide hourly RT LMPs, Ancillary Service Clearing Prices, and DA LMPs in August 2017. Five minute RT LMPs and Ancillary Service Clearing Prices will only be available in Data Miner 2. The Hourly RT and DA LMP flat CSV files will continue to be posted and available until February 1, 2018.

### 2. Generation Deactivation Charges

Mr. Ray Fernandez, PJM, updated the Subcommittee on the status of the Pseudo-Tie Generators and Dynamic Schedules Meter Error Correction working issue. PJM is targeting an early October implementation.
