Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct and Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the April 12, 2018 MSS meeting.

Members were asked to provide any updates to their NSPL scaling plans. No updates were provided.

Mr. Ray Fernandez, PJM, provided details on Settlement C processing in the April monthly invoice impacting the RECO zone. July, August, and September 2016 source data was adjusted, and additional processing will occur in the upcoming monthly invoices to adjust October 2016 through May 2017 source data. The May monthly invoice will also include a Settlement C adjustment for February 2018 source data in the DPL zone.

Working Issues

1. Membership Management Community Contact Management

Ms. Suzanne Coyne, PJM, introduced the Contact Management feature in the new Membership Management Community, which will allow members to assign and maintain contacts for specific business roles.

2. ARR Ownership Reassignments

Mr. Ray Fernandez, PJM, provided a reminder on ARR Ownership Reassignments and the June 1 implications. In order for PJM to accurately maintain and process the ARRs for an organization, PJM Settlements encourages and requests members to submit any known modeling changes that affect ARRs, and a list of any Directed Transfer Requests (dating back to February 15, 2018), to their Client Manager and/or PJM Settlements prior to the upcoming June 1st processing day.

3. FERC Order 825 – Discussion on Sub-Hourly Settlements

Mr. Ray Fernandez, PJM, updated the subcommittee on two changes to MSRS reports. The Balancing Generator LMP Charges report was changed from a maximum download range of 1 day to 7 days, and the Transmission Loss Credit Summary report will be updated to add a column containing the total PJM gen/load imbalance.
