## Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct and Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the August 16, 2018 MSS meeting.

Members were asked to provide any updates to their NSPL scaling plans. No updates were provided.

Mr. Phil D'Antonio, PJM, provided an update on the Market-to-Market Provisions regarding the East Towards-Hillside Tie Line. PJM and the NYISO are seeking a limited one time waiver effective September 17, 2018, for 1 year because they have not yet reached a resolution of issues related to the initiation, conclusion and settlement of M2M coordination on the East Towanda-Hillside Tie Line under the JOA

## Working Issues

### 1. Preliminary Excess Congestion Charge Allocation

Mr. Ray Fernandez, PJM, provided details on the excess congestion charges being allocated to net positive ARR targets. Members can utilize the ARR Target Credits report and the Revenue Adequacy report on the Financial Transmission Rights page to calculate their excess congestion charge allocation.

### 2. FERC EL05-121 Settlement Agreement

Mr. Ray Fernandez, PJM, gave an update on the additional interest component for the period of August 2018 through June 2019. The Estimated Current Recovery Charge (1108A) Interest and Estimated Transmission Enhancement Charge Adjustment (1115) Interest spreadsheets provide monthly details by zone or merchant transmission facility. ### 3. MSRS Basic Authentication and SUMA Updates

Mr. Nick DiSciullo, PJM, discussed the upcoming MSRS Basic Authentication updates and SUMA implementation. The Basic Authentication update requires members to update their existing processes as it is not backwards compatible. PJM is planning on releasing these updates to production in December.
