## Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct and Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the February 14, 2019 MSS meeting.

Members were asked to provide any updates to their NSPL scaling plans. No updates were provided.

Mr. Nick DiSciullo, PJM, provided details on Settlement C processing in the March 2019 monthly invoice impacting the AEP zone. October 2018 source data was adjusted.

## Working Issues

### 1. Energy Price Formation

Mr. Ray Fernandez, PJM, discussed the reserve market settlements related to the Energy Price Formation filing. Ray provided a high level settlements approach with regards to filing and new Billing Line Items. PJM plans to provide numerical examples, manual revisions, and a greater degree of information on this topic in future Market Settlements Subcommittee meetings.

No report changes were discussed.

## Future Agenda Items

A request was made for PJM to add a new column, ARR Market Name, to the ARR Target Credits report to help differentiate between ARRs that were originally allocated and ARRs that were distributed based on load shifts. PJM will provide an update at the next Market Settlements Subcommittee meeting.
