Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct, Public Meetings/Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the April 13, 2020 MSS meeting.

Working Issues

1. ARR Ownership Reassignments

Casey Noonan, PJM, reminded the Subcommittee on the June 1 implications of ARR Ownership Reassignments.

2. Regulation Market Settlement Agreement

Danielle Croop provided an overview of PJM's filing in Docket No. ER19-1651-001, in compliance with the Commission's directive in its March 26, 2020 order approving the April 23, 2019 Regulation Market Settlement Agreement. The settlement agreement impacts 16 energy limited storage resources that were operational prior to January 9, 2017 and continued to participate in the regulation market as of August 27, 2018. The duration of the settlement term is 42 months, and the term of the settlement will commence on July 1, 2020.

3. Update to FERC Order Requiring Reallocations and Refunds

Ray Fernandez, PJM, discussed cost allocation issues associated with multiple orders from FERC that require resettlement.

4. MSRS Report Updates – PRD and RPM Seasonal Capacity

Sean Flamm, PJM, reviewed the PRD and RPM Seasonal Capacity report designs. PJM is planning to make the reports available in the training environment during the week of May 25, 2020.
