Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct, Public Meetings/Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the July 16, 2020 MSS meeting.

Members were asked to provide any updates to their NSPL scaling plans. No updates were provided.

Sean Flamm, PJM, provided details on a Settlement C processed in the July 2020 invoice. There were adjustments for May 2020 reconciliation data that affected the DEOK zone.

Working Issues

1. UTC Uplift Allocation

Ray Fernandez, PJM, provided an update on the settlements impacts of the FERC Order directing PJM to allocate uplift to Up To Congestion (UTC) transactions. Settlement impacts include the allocation of Day-Ahead Operating Reserve Charges to UTC transactions and the addition of UTC transactions as a component of withdrawal deviations in Balancing Operating Reserve Deviations.

2. FERC Transmission Orders Requiring Reallocations and Refunds

Ray Fernandez, provided updates on cost allocation issues associated with multiple transmission orders (Dockets ER15-1387, ER15-1344, and ER18-680) from FERC that require resettlement and PJM's schedule for billing.

3. MSRS Refresh Project PKI Certificates

Sean Flamm, PJM, provided an update on the use of PKI certificates as applied to the MSRS refresh project. PKI certificate integration will no longer be included in the MSRS refresh project.
