 - In favor of proposed changes




Hourly Transmission Congestion Credit Report

Please explain your concerns with removing the End-of-Month FTR Credit column.


It is helpful to have the End-of-Month FTR Credit column in this report. That allows members to see deviations between invoiced credits (Hourly FTR Credit + End-of-Month FTR Credit) and Hourly FTR Target Credit in one report.

It is useful to have the hourly breakout provided by the Hourly Transmission Congestion Credits report. It helps in tying out changes due to FTR forfeitures and allocations of others' FTR forfeitures.
























