## Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct, Public Meetings/Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the January 18, 2022 MSS meeting. PJM paused for any outstanding questions related to Schedule 9 PJM administrative rate updates effective January 2022.

## Working Issues

### 1. Tools PKI Integration Discussion

Sean Flamm, PJM, reminded the subcommittee of the upcoming mandatory use of PKI certificates for browserless PJM tool use and also reviewed the integration timeline for PKI with specific PJM tools. PJM emphasized an ongoing reach out to CAMs to remind of the requirement of PKI use. Additional discussion occurred within the subcommittee on how to ensure PKI requirement information is communicated effectively and with urgency, and what the next steps would be if PJM is uncomfortable with PKI participation rate come scheduled go live dates.

### 2. Planning Period Congestion Allocation Summary Report

Sean Flamm, PJM, presented report documentation for a new MSRS report for FTR planning period congestion allocations.

### 3. FTR Forfeiture Compliance Filing Update

Nick DiSciullo, PJM, reviewed the recent FERC ruling on FTR Forfeiture rule compliance filing and provided next steps.
