## Administration (9:00-9:15)

- 1. Monica Burkett welcomed the group and announced that Manual 3 and 36 are currently going through endorsements and that the 2021 Gen Model Window is open until June 15.
  - A. Ashwini Bhat and Monica Burkett reviewed Antitrust Guidelines, Code of Conduct, Public Meetings/Media Participation, and Webex Participant Identification Requirements.
  - B. They also indicated that Webex report will be used to capture meeting attendance
  - C. Ashwini Bhat reviewed the agenda for the meeting. The agenda was approved with no objections and no abstentions.
  - D. Monica Burkett reviewed <u>minutes</u> from the April 16, 2021, RSCS meeting. The minutes were approved with no objections and no abstentions.

## PJM Compliance Activities (9:15-9:35)

- 2. Manual Updates
  - A. There were no manual updates.
- 3. Kyle Clifford, PJM, provided an update on <u>PJM Compliance Bulletin: CB029, NERC PRC-027 and other Protection and Control Series Standards</u>.

## FERC, NERC, and Regional Activities (9:35-9:55)

4. Becky Davis, PJM, provided an update on FERC, NERC and regional activities.

Becky mentioned that entity contact information will be updated and if there were updates entities were able to make updates until May 19, if there are additional updates, email can be sent to regional compliance@pim.com.

Becky reported on the following:

- Project 2021-01 Modifications to MOD-025 and PRC-019. The purpose of this project is to augment the "Applicability – Facilities" and "Applicability-Functional Entities" sections in MOD-025, MOD-026, MOD-027, PRC-019 and PRC-024 reliability standards to address (nongeneration) transmission-connected dynamic reactive resources – both rotating machine (i.e. synchronous condenser) and power-electronics based. Due date for Standard drafting team nomination was on May 20, 2021.
- NERC Rules of Procedure, Becky mentioned that comment period open for proposed revisions to the NERC rules of procedure due June 28 2021 and comments has to be submitted electronically to <u>ROPcomments@nerc.net</u>.
- She also mentioned about ERO Enterprise Issues Extension of Self-Logging Program Expansion and Deferment of On-Site Activities.



- Becky discussed about the NERC Reliability Risk Management and indicated that three Human Performance in Electric Power Virtual sessions are tentatively scheduled for July 15, October 21, and December 2 of 2021 from 1:00 - 5:00 p.m. Eastern.
- She also provided dates for Reliability First Technical Talks, RF Compliance Users Group, Operational Resilience Webinar and SERC Reliability Corporation, Registered Entity Training for Align.
- 5. Mark Kuras, PJM, made an announcement that there was a NERC PER-003 potential violation because of a Transmission Operator's losing NERC certification. He indicated that NERC Operators need to be NERC and PJM certified through periodic training. He also mentioned that the risk due to this violation is low as the person was previously NERC certified.
