Administration

1. Mr. Dave Anders opened the meeting and reviewed the agenda.
2. Ms. Cheryl Mae Velasco performed roll call, reviewed the meeting guidelines, and reviewed the draft meeting minutes. Minutes were approved and will be posted as final, with one change to attendee list.

Review Results of Phase 1 and Phase 2 Poll

Ms. Velasco presented the results of the poll that was distributed during the week of November 7th. There were 55 unique responders and 207 individual companies represented. The sector breakdown of the companies that participated was also provided. The number of votes for each package and the ratings it received was presented, along with the weighted total. Each package was then broken down into its individual rating distribution. If this was a binding poll, it would be difficult to determine which packages would pass since the poll was on a rating system versus a “yes”, “no” or “abstain” response. The results of the poll do not provide a strong argument for any particular package for either Phase 1 or Phase 2. Members expressed that a lower or zero rating does not necessarily mean a lack of support, but rather to show as much support for another package instead. After reviewing the poll results, two additional packages were proposed (package T). Dominion removed both of its packages from Phase 1 and Phase 2. Package M was removed from Phase 2.

Next Steps

A member expressed concern regarding voting without having a rate analysis performed on all the packages being proposed. The vote for Phase 1 and Phase 2 proposals will take place after the November 30th meeting.
