Administration

 Michele Greening provided a welcome, announcements and review of the Antitrust, Code of Conduct, and Public Meetings/Media Participation Guidelines. No media were announced as present. Stakeholders endorsed the draft minutes from the August 26, 2020 meeting as posted with no objections registered.

First Reads

2. Liquidation Process

Nigeria Bloczynski presented proposed revisions to PJM's default management process. The task force agenda referenced proposed use of the Quick Fix process outlined in Section 8.6.1 of Manual 34. Stakeholder discussion questioned the task force's ability to endorse a new Problem Statement/Issue Charge. PJM noted the issue would also be taken to the 9/17 MRC and committed to provide clarification as to the task force's next steps.

Clarification and next steps for the FRMSTF process was provided via notice sent to the FRMSTF email list on September 14 including the following excerpts:

...after due consideration and reflection, a new Problem Statement/Issue Charge will not be presented at the MRC as the scope of current FRMSTF Charter would include the efforts regarding the Liquidation proposal.

- As such, we will not review or approve a new Problem Statement/Issue Charge at the 9/17/2020 MRC.
- Rather, we will use the September MRC as a chance to conduct a first read of the proposal that was discussed at the 9/10/2020 FRMSTF, and we have posted both the proposal as well as related Tariff language for such first read. (Please note: These documents were posted last week and can be found on the <u>MRC page on</u> pim.com)
- PJM will review and will plan to conduct a vote on the proposal following the 9/29/2020 FRMSTF.
