At the Markets and Reliability Committee (MRC) meeting on Thursday, 7/28, the group voiced scope concerns regarding certain design components of the Underperformance Risk Management matrix. Ms. Carroll requested comments from the Senior Task Force members on how they wished to proceed. The group decided to review updates to packages submitted since the last meeting and direct questions of scope to the package sponsors at the August 17th meeting.
