Informational Filing

Dear Acting Secretary Reese:

PJM Interconnection, L.L.C. ("PJM") hereby submits this informational filing in the above-referenced proceeding to notify the Federal Energy Regulatory Commission ("Commission") that Rush Solar Project II, LLC ("Rush Solar") has withdrawn its project from PJM Queue No. AG1-224.

Rush Solar proposed to develop a 210-megawatt solar generating facility to be located in Rush and Fayette Counties, Indiana ("Rush Project"). On February 15, 2024, Rush Solar requested waiver of the requirement in section 309(B)(5) of the PJM Open Access Transmission Tariff ("Tariff") that the initial and proposed site must be adjacent parcels to permit a change to the site for the Rush Project.¹ Rush Solar asserted that it initially planned to develop its project in Rush County, Indiana, but because of a local moratorium on solar facility permit applications enacted on July 17, 2023, Rush Solar determined that the original Site was no longer viable.² PJM filed a motion to intervene out of time and protest to the Waiver Request on March 25, 2024.³ On April 5, 2024, the Commission granted Rush Solar's waiver request.⁴ On May 6, 2024, PJM requested rehearing of the Commission's waiver.⁵ On June 6, 2024, the Commission issued its Notice that the Rehearing Request is deemed denied by operation of law, but that the Commission will address the Rehearing Request in a future order.⁶
