Correction to Informational Filing of 2015 Annual Update

Dear Secretary Bose:

Virginia Electric and Power Company, doing business as Dominion Virginia Power (“Dominion”), hereby submits a correction to the Informational Filing of its 2015 Annual Update submitted on January 15, 2015 in the above-captioned docket. It has come to Dominion’s attention that there is an error in the calculation of the revenue requirements for Project BF-1 in Attachment H-16-B, Appendix A, Attachment 7. The “15,950,451” shown in the Informational Filing should be revised to “367,366” in Attachment A, page 67 of 73, in the second box from the left. In addition, because the revised amount is used to calculate other numbers in the formula rate, it affects several other amounts. Those amounts should be revised as follows:

- (1) Attachment A, page 67 of 73, in the two rows of numbers in the bottom of the second box from the left and at the bottom of the page:
  - (a) Both instances of “12,627,440” should be revised to “290,831.”
  - (b) Both instances of “3,169,291” should be revised to “15,505,900.”
  - (c) All four instances of “13,652,982” should be revised to “1,983,445.”
- (2) Attachment A, page 70 of 73, in the two rows of numbers in the first box from the left:
  - (a) The “199,765,234” should be revised to “188,095,697.”
  - (b) The “204,895,168” should be revised to “193,225,631.”
